## GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. Collect extinguishing water to prevent it from draining into the sewer system. Dispose of contaminated water used for extinction and the remains of the fire according to applicable regulations.

## SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters.
